## **Legislative Update**

SB 993 - Would require all businesses that do not meet certain exemptions to levy and pay a sales tax on their services. (Heard in Senate Governance and Finance Committee 5/16/18)

AB 1938 - Would prohibit an employer from inquiring about whether a job candidate has children. (In Assembly Labor and Employment Committee 3/8/18)

AB 2705 - Would create a 2 year statute of limitations for claims of non-payment of workers' compensation by contractors. (Enrolled and sent to Governor 8/24/18)

SB 1272 - Would help fight the underground economy. This hurts the pool industry by skirting the laws on taxes, workers' compensation, licensing and more, creating an unfair marketplace in which it is increasingly difficult to compete. (Approved and sent to be enrolled 8/31/18)


