Effective April 1, 2011 the following changes will be made to your IPSSA business liability insurance:

• Property damage deductible will increase to \$500 from \$250;

• Requirement that subcontractors carry liability limits of \$1,000,000 instead of \$500,000

Find the Proper Place to Drain a Pool

(advice from Ray Arouesty at Arrow Insurance)

Local ordinances mandate where a pool can be drained. Some municipalities will not allow a pool to be drained to the sewer due to high levels of heavy metals. Other areas restrict draining pool water into the storm sewers. I'm told that South Pasadena required the water to be taken to a class 3 dump by truck. So, the best approach is to check with the locality.

Oh yes, and NEVER drain a pool into a septic tank!
