Presidents Message

Have a great April!

Our swim season has started! Solar systems are now being turned on! I have already had kids swimming and backyard parties happening! Lets take a moment and talk about safety. It is our responsibility to make sure our pools are safe and ready to use. That means checking that gates are self-latching, main drain covers are all on and secured, vac locks are installed on all suction cleaner lines, and pools must be clear (not cloudy!). Watch out for those painted pools, they can be a death trap when the paint comes off and clouds the water! The other things to check are all the electrical connections and bond wires to pumps, heaters, and time clocks. (Including the time clock shock protectors). Customer will be turning them on when having swim parties. Lately, I have been on two jobs with dangerous heater installs! One was under a deck and less than 3 feet from a window, I

was not there for the heater, but I had to inform the customer of the danger and I disabled that one, the other was a heater service call. It was installed too close to window and right up against a wood shed right next to the house. (so close I could not even get to the temp sensors on the header). That one I bid to relocate heater and then fix the problem. Customer had no idea of how dangerous heaters can be. They may not like the addition cost, but It can save a life or a house burning down! Make sure you are watching out for your customer's safety! This is a must part of our professional work we preform everyday!
