PSATC MISSION

IPSSA Education Fund Revisions

Under the revised program benefit, applications can be reimbursed up to **\$500**; with one reimbursement approved in a calendar year. In accordance with these guidelines, the following classes qualify (not exclusive):

- Industry Trade Show education offerings
- Professional Certifications: Certified Pool Operator (CPO) and Aquatics Facility Operator (AFO)
- Contractor license schools
- Manufacturer-sponsored courses
- College-level courses in: Bookkeeping, accounting, computers, and chemistry
- Trade-school courses in: Plumbing, electrical, and mechanical

The individual application packet must be received within 90 days of successful course completion. Individuals that received a discount on a class sponsored by IPSSA are not eligible for a Scholarship for the same class. Eligible individuals may download the application from ipssa.com or email info@ipssa.com. Applications are reviewed quarterly by the Education Fund Committee. 
